PRESIDENT-ELECT



Brian Richardson L & A Tent Rentals Trenton, N.J.

Brian Richardson is president and CEO of L & A Tent Rentals, Trenton, N.J. In this role, Richardson oversees day-to-day company operations, delegates and directs agendas, drives profitability, and manages organizational structure and strategy. L & A Tent Rentals opened in Hamilton, N.J., in

1986, and today employs 22 full-time staff year-round, a number that increases to nearly 50 from April to November. In addition to L & A Tent Rentals, Richardson, along with his son and son-in-law, recently opened New Jersey Event Services — a standalone event restroom and golf cart rental business.

Background: "I started working part-time for a local tent company in my home state of Maine while in high school. After high school and a couple of years working in the grocery industry, I went to work full-time as a project manager for Lewiston Auburn Tent & Awning Co. in 1980. I would travel throughout the Northeast and mid-Atlantic installing tents for fairs, festivals and sporting events. I met my wife of 34 years, Kathleen, while setting up tents for a 4-H fair in New Jersey. For more than 20 years, I have led training and education sessions for various tent and special event-focused organizations. After starting two separate rental operations from scratch, I believe I have gained valuable insight into successfully managing the fiduciary responsibilities of an organization. I have expertise in strategic and long-range planning, business development, and relationship building, along with big picture thinking to see the broader vision of what needs to be accomplished in an organization," Richardson says.

If the members select you as the next president-elect — and ultimately you serve as president and board chair — what do you hope to accomplish?

"All effective leaders must have a long-range vision yet also recognize that they must remain agile in the face of everchanging environments. Our association has faced numerous challenges in the last few years and will most likely face more in the future. We must have the ability and resolve to pivot when faced with unforeseen trials and remain resilient when confronted with unpredictable circumstances.

I would like to see ARA continue as the driving force in industry-related education and training. I will encourage members to take advantage of the opportunities available via ARA and RentalU. On the equipment side, the certification programs for MEWPs (mobile elevating work platforms) and forklifts have been terrific additions to RentalU. For event rental operators, we have educational partnerships with both ATA and MATRA to develop training courses on safe tenting. Partnerships like these benefit the entire industry and highlight ARA as the foremost resource in education for the equipment and event industry.

We must also focus on leadership development. I will endeavor to foster relationships between people with different areas of expertise and from different backgrounds to encourage more volunteerism in our industry."

Kevin Karcher Jr. InTENTional Systems (formerly Eureka! The Tent Co.) Binghamton, N.Y.

Kevin Karcher Jr. is a regional sales representative with Binghamton, N.Y.-based InTENTional Systems (formerly Eureka! The Tent Co.). He is responsible for supporting customers in the Northeast and mid-Atlantic through

sales, service, technical support and marketing initiatives. Tasks ranging from the creation of sales budgets to fostering rewarding relationships with customers are core to Karcher's positions with the company.

InTENTional Systems is a collective of people who are passionate about tents, Karcher says. The company combines the legacy of Eureka! party tents — which dates to 1895 — with new resources aimed at growth, expansion and the positioning of the company as one of the event rental industry's premier tent brands. InTENTional Systems specializes in party tents, pole tents, frame tents, keder frames, high-peak frames, canopies, clearspan structures, sidewalls/lighting and accessories.

Background: "My experience in rental goes back more than 30 years to high school, when I started working in a general tool/party store. I worked my way from waving to traffic for the store's grand opening to cleaning and maintaining small equipment to running the rental counter. After graduation, I worked in two rental stores where I learned about tent installation and event rentals. After serving in the Coast Guard, I opened my own event rental company. With a great team, we expanded our inventory to include tents and amusements. I worked every aspect of that business, from warehousing and cleaning to sales and installation — I did it all. After more than a decade of managing that company, I transitioned it to other owners and began working with an independent manufacturer rep agency, selling their products to both segments of the rental industry. I later took control of the company as its owner retired. I continued to support the rep agency until I

accepted a position with InTENTional Systems. I continue to be a principal partner in that agency — which represents associate member companies Bon Tool Co., PHP Distribution and Granite Industries — alongside my responsibilities with InTENTional Systems," Karcher says.



REGION THREE DIRECTOR




Brandon Ahlgren, CERP Elite Events & Rentals Tampa, Fla.

As I planned its community events, I worked alongside local rental companies to secure tents and other rentals. It was then that I first began to see the rental industry as a possible career path. finding ARA that I was really able to connect with those who would be instrumental to my success. Jared Medaris, CERP, is CEO of Expo Events, Fresno, Calif. He took over the role in January 2024 after spending 10 years as company president and has transitioned from an operations focus to a concentration on

big picture matters like financial health, company culture, executive team oversight, strategic planning and HR.

Expo Events was founded in 1987 by Mario and Connie Viramontes as Exposition Décor, a trade show decorating company. The company later shorted its name to Expo Décor and as it grew added several divisions, including event rentals. The company employs 55 today and Medaris — who has been with Expo since 2003 — currently is in the acquisition process of a stock purchase with the previous owners/founders of the company.

Background: "My experience in the rental industry began when I started working at Expo Events 21 years ago in an office/sales position. In 2005 I was made head of the party rental division. I was promoted to vice president of the company in 2012, and in 2014 I was promoted to president, while still overseeing the party rental division. During the past 21 years I have worked in many different aspects of the business, including sales, warehouse, delivery, human resources, hiring, training and whatever else needed to be done. In 2014 I attended The ARA Show™ for the first time, and during that show I really saw the value in networking within the Association. As I have gotten more involved, I have had more exposure to the other segments of our industry. Serving on the board of the ARA of California has given me the opportunity to make visits to multiple member locations from all segments and see their operations," Medaris says.
