# PRESIDENT-ELECT



#### Robert H. Pedersen A Tool Shed Santa Cruz, Calif.

Robert H. Pedersen is president and CEO of A Tool Shed, Santa Cruz, Calif. The family business, founded by Robert and Geneva Mac Ardell, began as White Elephant Sales, an Army surplus store in Sunnyvale, Calif., in 1945. Under the leadership

of Robert Mac Ardell through 1964, A Tool Shed grew and, with other rental companies in California, helped form the California Rental Association (CRA). The company grew from a single store location to 10 locations under the leadership of Robert's father, Larry Pedersen, who passed away in 2008. At this time, Robert, who came into the business full time in 1983 after receiving his degree in business management and economics from the University of California, Davis, took over the leadership of the company and is the current president and CEO. The company currently has eight locations and 94 employees in four counties of California's Silicon Valley.

**Background:** "I have been involved with our rental business in one way or another my entire life. I remember picking up shop rags around the stores for a nickel apiece in grade school, rebuilding engines while in high school and setting up canopies on a rainy New Year's Eve. I had other options, but chose a career in the rental industry and our family business. When I came on board full time in 1983 and with my brothers' help, we added six new locations to the three we were currently running. At the same time, my wife, Barbara Pedersen, opened A Party Place, our party and event rental division that ultimately grew to three locations before we sold it in 2001. Throughout my career, I have volunteered time to the rental industry that has given so much to our family over the years," Pedersen says.

Sinai Hospital and the Gastro-Intestinal Research Foundation at the University of Chicago.

The company is currently under the leadership of President and CEO Cesar Lanuza, and provides maintenance and repair products including hydraulics, fasteners, electrical, chemicals, cutting tools, abrasives and safety equipment. Lawson Products joined the American Rental Association (ARA) in 2017 and also has exhibited at The ARA Show<sup>™</sup>.

**Background:** "Prior to my experience with Lawson Products, I was VP, Marketing and Human Resources, for a large banking company. I was responsible for designing and executing all marketing initiatives to drive revenue, all corporate communications, and all HR functions. Tates Rents has 150 employees, and primarily focuses on construction and general tool equipment. As of 2019, Tates Rents has become employee owned.

Background: "In 2006, I just got back from the University of Cincinnati studying accounting. A roommate of mine suggested that I work at Tates Rents and said, 'You won't get rich, but you will love your job.' When I started my career, I worked at our Eagle store location. I started out doing inside sales and also wash pad work. I established myself as a leader in the company and started doing floating shifts at other stores whenever they would need to be filled. This gave me vast experience and knowledge of what we had to offer. I then went to the Meridian store three years later and was assistant manager for two years until my true ambition — outside sales — became available. Since 2010, I have been doing outside sales for the company at an astounding growth rate year after year. I recently celebrated my 17th year with the company. Brincheski founded Collective Event Rentals, formally C&T Event Rentals, in July 2016 after working in her family's equipment rental business, C&T Rentals & Sales, for many years. "I saw a need in the Winnipeg market for a modern event rental business and decided to take a leap from equipment rentals and start an event rental business," she says.

Since 2016, Collective Event Rentals has acquired two event rental businesses — Swank Event Rentals in 2018, a company that specialized in event furniture, and Bel Ayre Rentals in 2020, a family-owned 35-plus-year business. In 2021, the company completed construction on its new 28,000-sq.-ft. store and combined all businesses under one name — Collective Event Rentals. In 2022, Collective launched a wedding and event venue, Novella at Collective, an event space that can host up to 150 guests on the second floor of their location.

**Background:** "I have been involved with the rental industry full time since 2010. I started working in my father's equipment rental business after completing my Business Administration Diploma from Red River College. From 2010-2016, I worked in numerous roles within the company. I started as a rental counter associate then progressed to managing our accounts receivable. I became our office manager and finished as the branch manager of our busiest equipment rental location. I was also a designated safety auditor and oversaw our COR\* [Certification of Recognition Program] certification. I strive to be innovative, detailed and adaptable, all of which help with forward thinking and being a big picture thinker," says Brincheski.
